ADDITIONAL CANDIDATES

Article III Section 3 of the ARA Bylaws allows for additional candidates to be placed on the ballot in addition to the Nominating Committee's selections. Additional qualified candidates may be placed in nomination by petition signed by at least 5% of the current members (as of 4-30-2018 = 8228). The petition is to be filed with an ARA administrative officer at least 45 days prior to the election. ARA then is to mail notice of the additional nominees to all members at least 30 days prior to the election.

For 2018, the following applies:

>Minimum number of names on a petition: **411** (i.e., 5% of 8228)

>**August 3, 2018**—Petitions to ARA

>**August 20, 2018**—Notice to members of additional names
